 On November 23, 2014 at approximately 10:58 am I, Senior Officer Specialist S. Grogan, conducted an area search of cube 17 in the camp. Cube 17 is assigned to inmates Cruz, Romeo 16160-067 and Dressler, Lawrence 21502-014. In the area search of cube 17 I found a bag of spiraled pasta in a net bag that was hanging on a hook in cube 17. This spiral pasta is not sold through the commissary and is part of the food service supply. Inmate Dressler admitted that the pasta was his and that he took it from the warehouse.
