**Affidavit**

The undersigned affiant, being duly sworn, deposes and says:

- The undersigned, Detective K. Cuddy, being duly sworn, does depose and state that she is a member of the New Haven Police Department and has been since October 16, 2002. At all times mentioned herein, she was acting as a member of said department. The following facts and circumstances are stated from personal knowledge and observations as well as information received from other police officers acting in their official capacity, police reports and statements made by prudent and credible witnesses.**
- Due to Connecticut General Statute 54-86e the victims name and address will be withheld from this affidavit.**
- On August 9, 2016, Sgt. Segui assigned me an investigation into a sexual assault. I was given a copy of email correspondences between Sgt. Segui and the victim's Attorney Chris Mattei regarding sexual assaults that had been perpetrated by Rabbi Daniel Greer (DOB 6/15/1940).**
- On August 25, 2016, Detective Kendall and I met with the victim (DOB 10/21/1987), at police headquarters to get a formal statement, which was both audio and video recorded. The victim stated that he had attended The Gan School also known as the Yeshiva School, located at 195 Norton Street in New Haven CT. for high school. The victim attended the school during the years of 2001 through 2005 and graduated from said school. During those years Rabbi Daniel Greer was the Dean of The Gan / Yeshiva School.**
- The victim stated that during his sophomore year, September 2002 to June 2003, when he was approximately 14 or 15 years of age, Greer told the victim to meet him at 777 Elm Street, 1st Floor, New Haven CT. Once at this location Greer supplied the victim with alcoholic beverages (usually Bloody Marys, Single Malt Scotch or Wine) and they began to engage in an emotional conversation. At that time Greer was seated next to the victim on a couch and leaned in and kissed the victim**




on the mouth. The victim stated he "freaked out" and Greer told him "I do it (referring to the kiss) to all my kids." "It's normal." The victim then left the apartment without further incident.

- A week or two later the victim was instructed to meet with Greer again at 777 Elm Street, New Haven CT., which he stated was prior to his birthday in October, which made the victim only 14 years of age, and while at 777 Elm Street, New Haven, CT. Greer again gave him alcoholic beverages while seated on a couch side by side. Greer then made the victim stand as Greer remained seated on the couch. Greer opened the victim's belt, pulled the victim's pants down, which fell to his ankles followed by Greer putting the victim's penis inside Greer's mouth.
- After that incident, the sexual assaults became a "regular thing." The victim would be told to meet Greer at least once a week, at a residence that was owned by Greer or the school and during each of those meetings the victim was sexually assaulted by Greer. The victim stated that he was sexually assaulted at all of the following locations in New Haven, CT. 777 Elm Street, 203 Norton Street, 209 Norton Street, 439 Edgewood Ave., 193 Maple Street, and 139 Park Street. The victim stated that he was sexually assaulted so frequently by Greer and at the same locations he was unable to distinguish one sexual assault from another. The sexual assaults mostly occurred during evening hours or on Sunday afternoons.
- As the sexual assaults continued they escalated in nature. The victim described an incident when after Greer gave him alcoholic beverages at one of the above mentioned locations, Greer took the victim into the bedroom. Greer removed his own clothes and then undressed the victim. Greer and the victim then got into what the victim described as a "69" position. Upon further questioning the victim described "69" as him laying naked on his back on the bed while Greer was naked on top of him. The victim had Greer's penis inside his mouth and Greer had the victim's penis inside Greer's mouth.
- On a different date the victim was told by Greer to meet at one of the locations and Greer again would undress himself and then undress the victim. This occurred inside the bedroom of the location. Greer would then "get into the doggy position" which the victim described as, Greer being naked on all fours or hands and knees. Greer would then hand the victim KY Jelly lubrication and instruct the victim to put his penis inside Greer's anus, which he did. The victim stated that the majority of the sexual assaults involved the victim usually penetrating Greer's anus with his penis, however, the victim stated that he was also penetrated in the anus by Greer's penis. The victim told Greer that he "didn't like it" regarding being penetrated by Greer's penis but it continued regardless.
- The victim stated no condoms were used only KY Jelly lubrication. During the sexual assaults the

victim stated that he had ejaculated inside Greer's anus, mouth and on Greer's stomach on different occasions. Greer would ejaculate on the victim's chest after oral sex because the victim told Greer he did not want the ejaculation inside his mouth.

11. If the victim refused to meet with Greer, he would be punished by Greer with bad grades, Greer would yell at the victim in the hallways of the school and threaten the victim with expulsion from the school. The victim described the sexual assaults as "a game" for Greer.
12. The last time the victim was sexually assaulted in New Haven, CT. by Greer was after he graduated from The Gan School / Yeshiva in June 2005.
13. The victim described Greer's body as having no tattoos, orange pubic hair (which may have changed color due to age), a circumcised penis, a hairy back and chest, a mole on his upper back and as having a scar approximately one to four inches long on either his left or right leg near between his thigh and testicle. The victim stated that the scar on Greer could only be seen if Greer was naked. [REDACTED] also said at that time of these sexual assaults Greer would always put his shoes on before his pants, but did not know if that had since changed.
14. On June 16, 2017, I applied for and was granted a Search and Seizure warrant for Daniel Greer's naked body to be video taped and photographed by the honorable Judge Fischer.
15. On June 20, 2017, Sgt. Zannelli, Detectives Monzon, Parker and I met with William Dow III and Daniel Greer at Jacobs & Dow, LLC Office, located at 350 Orange St., New Haven CT. to execute the search and seizure warrant of Greer's unclothed body. This meeting was facilitated by Sgt. Zannelli. Detectives Monzon and Parker photographed and videotaped the clothed and naked body of Greer in the presence of Attorney Dow III in a private room. Attorney Dow III stated that his client, Greer, would not be giving a statement to police.
16. Detective Parker gave me a DVD-R that contained all the videos and all photographs taken of Greer. Upon reviewing the video and images I found that the victim's, statements in regards to Greer's naked body were all corroborated. The images clearly showed that Greer did in fact have a lot of pubic hair, orange in color, an extremely hairy chest, white in color, an extremely hairy back, black in color. Also, small mole on the upper right side of his back, a small circumcised penis and a scar on Greer's body one to three inches in length between the right thigh and right testicle. I also noted while watching the video of Greer undressing that he removed his pants while wearing his shoes. The victim had stated that Greer would put his pants on while wearing his shoes, although today he did the opposite, it is an odd behavior.





17. I was able to locate, a separate victim, A.K.'s deposition for the civil lawsuit by the victim v. Greer online, and upon reading it, I found it further corroborated the victim's statements and added additional information regarding Greer's crimes. In the deposition A.K. stated that he had sexual relations with Greer on "many, many, many occasions." H.K. described being given alcohol by Greer, receiving, giving oral sex, and sodomy. H.K. stated that the sexual assaults occurred weekly and that he observed Greer's relationship with the victim change. Greer began spending more time with the victim taking "too much of an interest." A.H. also stated in his deposition that Greer told him "You know I do this with the victim," referring to his weekly sexual encounters. The victim also confided directly to A.H. that he was having a sexual relationship with Greer.

18. I contacted the victim via phone and requested any documentation that he had to prove he had been a student at Yeshiva of New Haven. The victim emailed me his **ACADEMIC REPORT** for Grades nine through twelve (2001 to 2005), which clearly shows the schools address, the victim's name and the final page of documentation was a Transcript Legend for the Yeshiva of New Haven that has Rabbi Daniel Greer listed as the Dean of the school.

19. Wherefore, the undersigned believes that probable cause exists that Daniel Greer (D.O.B. 6/15/1940) has committed the crimes of Sexual Assault in the 2nd Degree and Risk of Injury in violation of C.G.S. 53-71 and 53-21.
