AFFIDAVIT OF COUNSEL AND CERTIFICATE OF GOOD FAITH

Pursuant to Conn. Prac. Bk. § 1-23, I, Michael W. Brown, hereby state:

- (1) I am over the age of 18 and understand the obligations of an oath.
- (2) I am an attorney licensed to practice in the State of Connecticut.
- (3) I represent the petitioner in the above-captioned matter.
- (4) The facts relied upon to show the grounds of disqualification are such as appear from (A) a review of the publicly available information related to the judicial authority, including the nomination proceedings before the legislature, and (B) a review of the attached judicial branch printout demonstrates that the Connecticut Supreme Court decided several motions and rejected a number of appeals from the petitioner's litigation during the time period that the judicial authority was employed as a permanent clerk at the Court.
- (5) The nature of the appellate court process and the working of the court makes it impossible for the petitioner to assert with certainty the level of the judicial authority's involvement with the petitioner's prior appellate matters, but the judicial authority's presence in the role as a clerk at that time is sufficient to demonstrate an appearance of impropriety.
- (6) This Motion for Recusal is made in good faith and in furtherance of the

petitioner's rights.

(7) I have read the foregoing and believe the statements are true and complete to the best of my knowledge and belief.


