AGREED STATEMENT OF FACTS

1. On Sunday, May 21, 2023, at approximately 8:58am, Attorney Jonathan J. Einhorn ("Einhorn") completed and signed the 'Notification To Visitors and Request to Visit Detainee Form', completed each time a detainee is visited at the Wyatt Detention Facility ("Wyatt"), for inmate Anthony Whyte ("Whyte"). Einhorn signed and dated this document that contains the following certifications:

- 2. In part, the 'Notification To Visitors and Request to Visit Detainee Form' states: "It is unlawful to bring upon the institution grounds any weapons, intoxicants, drugs or other contraband...I declare that I do not have any articles in my possession which I know to be a threat to institutional security."
- 3. The Wyatt Correctional Officer stationed in the lobby asked Einhorn during the search process if he planned on passing any paperwork to detainees he was visiting. The Corrections Officer asked, "Are you gonna be passing anything to the detainees today?" When asked this question by the Correctional Officer, Einhorn responded "No, not today."
- 4. On May 21, 2023, Einhorn visited with several clients at Wyatt. Wyatt's Professional Standards Unit ("PSU") observed Einhorn pass paperwork to at least two of the detainees he met.

- 5. During Einhorn's visit with Whyte, Einhorn was observed passing Whyte a manila envelope. Whyte placed the envelope to the side and did not touch the envelope until the visit was nearly concluded. At that time, Whyte removed the contents of the envelope, flipped through the pages, placed them in between other paperwork he brought with him, and inserted the envelope into the pages of a book.
- After the visit was complete, Whyte was placed into the detainee waiting room. PSU then seized all Whyte's paperwork. All the seized material was then brought to PSU and photographed. During a search of Whyte's paperwork, PSU located eight (8) pages that Einhorn passed to Whyte during the meeting, which were discolored and highly stained. PSU believed these pages had been treated with a contraband substance. The eight (8) pages were packed and placed into evidence by the PSU.
- 7. Four (4) of these pages were printed with an unofficial academic transcript for Whyte's son, showing a date of May 19, 2023, at 1:55pm, a one (1) page document from the National Student Clearinghouse showing the son's Current (college) Enrollment Verification and three (3) pages of athletic grant paperwork from a Connecticut college's athletic department. The seized paperwork was consistent with discussions between Whyte and his son in the days leading up to May 21, 2025.
- 8. Einhorn received these eight pages from Whyte's son in Connecticut on May 19, 2023. Einhorn brought the documents to Wyatt with the intention to deliver them to Whyte.
- On May 25, 2023, the eight pages seized from Whyte on Sunday, May 21, 2023, were obtained by the Federal Bureau of Investigation from PSU. These items were later entered into FBI evidence.
- On June 20, 2023, the seized paperwork was shipped to the FBI Laboratory for testing. One of the eight pages seized from Whyte was selected for chemical analysis. A report generated by the FBI Laboratory on July 31, 2023, identified that the examined page from the original eight pages that were seized from Whyte contained three synthetic cannabinoids, 5F-ADB, ADB-4en-PINCA, and MDMB-4en-PINACA. 5F-ADB is a synthetic cannabinoid and a Schedule I controlled substance. The formal name for 5F-ADB is Methyl 2-(1-(5-fluoropentyl)-1H-indazole-3-carboxamido)-3,3-dimethylbutanoate.
- On April 23, 2023, Einhorn had visited Whyte at Wyatt. Similarly to May 21st, a Correctional Officer asked Einhorn if he would be passing anything to an inmate to which Einhorn responded negatively. Thereafter, Einhorn was observed passing documents to Whyte during this April 23rd meeting. The documents were not seized.
